Government takes information to the people

The Government Communication and Information System (GCIS) together with the Mafube Local Municipality and Karabo ya Setjhaba hosted two economic opportunities programmes in Villiers as part of educational awareness about opportunities, both economic and skills development, that community members can access. The event took place on 14 November 2017.

Villiers is one of the towns within the Mafube Local Municipality that has the potential to be the economic breadbasket of the Fezile Dabi District Municipality. Due to its strategic geographically location that links Gauteng and KwaZulu-Natal. The N3 highway alone makes it ideal for transport-related job and skills development opportunities to thrive. It is also good for tourism opportunities as former President Nelson Mandela was once detained in this town. The area also has a flowing river that which can be used for water-related sporting activities, which can bring tourists to the area. The river can also be used by those who are interested in fish farming.

During these programmes, the GCIS was supported by stakeholders such as the Small Enterprise Development Agency, National Youth Development Agency, Department of Trade and Industry and the National Lottery Commission. During the sessions, community members were provided with information on how they could register their businesses, apply for funding and also drafting a business plan. These educational programmes were executed as outcome-based initiatives as requested by community members.

Workshop to empower businesses

The Department of Economic Development together with economic partners within the Abaqulusi Local Municipality organised the Business Development Information Dissemination Workshop to empower small businesses and cooperatives in Ward 5 and surrounding Mnyathi and Vumani areas.

Local business owners and aspirant businesses and cooperatives attended the workshop at Xulu-Msiyane Community Service Centre on 9 November 2017.

The Small Enterprise Development Agency (SEDA) and South African Revenue Service (SARS) covered topics on business formation, compliance regulations and skills development, which are important for any business development.

The departments of labour, rural development and land reform, agriculture, forestry and fisheries, economic development, tourism, environmental affairs and the Abaqulusi Department of Local Economic Development presented on government programmes to develop small businesses and also provide information on marketing opportunities and access to funding and training.

Ward 5 Councillor, Mdititi Ntombela, explained that Mnyathi and Vumani areas are far from town and it is expensive to travel to town to access information.

"We will make it possible for businesses to access business development information frequently. We will also ensure that we measure the impact of success after each workshop. We will also assist those businesses that have challenges to overcome them," said Ntombela.

Hlanganani Buthelezi from SEDA encouraged people to use the agency's services to run and manage their businesses well. He mentioned that the agency provides non-financial support, training and marketing to prepare small businesses to become formal ones that can make profits.

People raised concerns of lack of access to SEDA and SARS services within the municipal areas, which affects business development adversely. The matter was referred to Abaqulusi Local Municipality to be attended to immediately.





Ntuthuko Myeza said:

"The department has been providing training on soft and technical skills in the area in partnership with UMthashana Technical Vocational Education and Training college. This is our first workshop at this centre to ensure that businesses in this area are given information that will prepare them to be ready to seize business opportunities when they arise."

"It is an amazing thing. It will bring services to us. When I applied I had many problems with signatures and I had to rent a place in Kimberley for three months just to get started and receive fax messages. So I am very pleased. They helped me before and I still need them for more assistance."



Christopher Telero said:

"The offices here are much easier to access. Bursaries, starting your own business and access to information is what the youth can look forward to. Going there will be easy for us. Youth in rural areas have been struggling a lot, but that has changed for me and my community. I am from Bankhara Bodulong."

NYDA opens offices in the John Taolo Gaetsewe District

The National Youth Development Agency (NYDA) launched a district office in the John Taolo Gaetsewe District on 13 October 2017. The new office will give young people in the district access to its services. In the past, the NYDA came to the area either on invitation or sporadic visits, but with the new office, services will be available daily.

Keneilwe Holele is one of the many beneficiaries of the NYDA assistance programme. She is the managing director of a company called Perfume by Kene, which is based in the John Taolo District. She received a grant from the NYDA to buy machines for bottles. Keneilwe currently has one employee who is a distributor and has clientele in Kimberley, Upington and Kuruman. She wishes to open and distribute her perfume in other provinces and also employs two more distributors and two permanent staff members in Kuruman. She hopes that with the offices of the NYDA in the district, she will be able to do that.

The opening of the NYDA offices comes as a relief after many years of young people having to travel over 250km to access the services in Kimberley.
