The Deputy Minister of Public Service and Administration, Sindisiwe Chikunga, embarked on a monitoring visit to Port Shepstone Thuthuzela Care Centre on 6 September 2019. The Deputy Minister met with Port Shepstone Regional Hospital Management and the KwaZulu-Natal Acting Head of Department of Health.

The purpose of the visit was to monitor and evaluate the work done so far, especially in dealing with numerous cases linked to the gender-based violence (GBV), as the country observes Public Service Month.

Deputy Minister Chikunga strongly condemned notorious acts directed to women in the country and urged law-enforcement agencies to deal with all perpetrators. She referred to Thuthuzela Care Centre as a one-stop station where victims of GBV canreceive all services. The Deputy Minister also noted all concerns that are faced by health institutions in the province and promised that they would be channelled to relevant authorities at national level.

Minister opens Sexual Offences Court

The Minister of Justice and Correctional Services, Ronald Lamola, officially opened the Sexual Offences Court at Sibasa, Limpopo on 13 September 2019. The sexual offence courts were reintroduced by the Department of Justice and Constitutional Development in 2013 to provide specialised redress to victims of sexual abuse and gender-based violence (GBV), and also to reduce the turnaround time in finalising these matters before court.

According to the Minister, the opening of this court was aimed to fast-track the government fight on GBV cases. "The primary role for the sexual offences courts is to provide specialised services to victims of GBV. This court will not leave any stone unturned. We will make sure that there are no perpetrators of GBV who escape the rule of law due to delays from the judiciary processes. GBV is becoming a societal challenge than ever. That is the reason government is left with no other choice than taking aggressive action to root out all forms of GBV and related crimes," said the Minister. He further indicated that nobody is above the rule of law.

One of the community members who were in attendance, Alunamutwe Rannditsheni, said, "Today I am going to have a peaceful sleep without thinking of praying to God for the solution of bringing the rule of law in South Africa. As a servant of God, we were so touched about the situation faced by women in the country. Today, I feel relieved when government starts taking action, which will protect the dignity of women."
