## Awareness on gender-based violence and femicide

Nkangala Men's Sector, Ithemba Victim Support, Emakhazeni Victim Empowerment, Emakhazeni Municipal Speaker, Councillor Nomhle Mashele, in collaboration with the Government Communication Information and System, conducted a gender-based violence and femicide (GBVF) march at the Waterval Boven N4 road intersection on 4 September 2020.

There is a high number of GBV cases in Waterval Boven and majority of the victims are students from Nkangala TVET College's Waterval Boven Campus. The students live in fear of being possible victims as most cases go unreported or unsolved when reported.

The Nkangala District Men's Forum chairperson Cassim Fakude said, "It is worrying that the conviction rate in many of the reported cases is low, some of the cases are not thoroughly investigated and the suspected perpetrators are seen roaming around the streets."

The march was organised to raise awareness about GBVF and prioritisation of related cases by law-enforcement agencies and the justice system. Various information leaflets were distributed to motorist and community members. ## **Deputy Minister monitors COVID-19 compliance**

The Deputy Minister in The Presidency, Thembi Siweya, undertook a monitoring visit to the Free State on 27 and 28 August 2020 respectively. The Deputy Minister started by visiting the Bloemfontein Magistrate Court, where, together with the MEC for Police, Roads and Transport, Sam Mashinin, i assessed the impact of COVID-19 on service delivery.

The court management gave the presentation on court performance with focus on sexual offences and child maintenance office. Deputy Minister Siweya identified the infrastructure and structural challenges, which have the potential to hamper efficiency in service delivery.

The Deputy Minister then pointed out the need for the court to review its structures to accommodate more intermediaries to support victims of gender-based violence when they testify at dedicated sexual offences courts. The presentations was later followed by the walkabout around the court and both Deputy Minister Siweya and MEC Mashinini were pleased with the court's level of compliance to COVID-19 regulations.

On 28 August, the Deputy Minister then visited Letsweng Cooperative in Maokeng, accompanied by the MEC for Agriculture and Rural Development, William Bulwane and the Executive Mayor of Moqhaka Local Municipality, Justice Mareka. The cooperative does aquaponics agriculture, funded by INMED Aquaponics.

The Deputy Minister's visit was to monitor the recovery and how the centre operates during COVID-19 as most of the staff members are people with disabilities and comorbidities, and this makes them vulnerable to the virus. The Deputy Minister provided words of encouragement to the centre and advised on how it can adopt to the new normal.

Ntswaki Tolo, the centre manager, said they lost lots of fish during the lockdown and experienced vandalism as they do not have security in the centre. She said they also had to close the centre due to the virus because most of the workers in the centre have chronic illnesses. Unathi Sehlahla, INMED Aquaponics manager, said that aquaponics agriculture helps to ensure sustainable food security in South Africa.
