Government launches sexual offences court

The community of Botshabelo has experienced the most horrific incidents of sexual offences in the past. The Department of Justice and Constitutional Development, through its efforts of rooting out gender-based violence and sexual offences, responded to the challenge through the opening of a special Sexual Offences Court in Mangaung Metro.

The court was officially opened by the Minister Michael Masutha at Botshabelo on 24 November 2018. The Minister expressed gratitude for launching the 76th Sexual Offences Court in the country and emphasised the importance of stakeholder involvement toward realising the objectives of the court. Among others, the court is aimed at fast-tracking and concluding sexual offences cases in the shortest period of time. The Minister further encouraged community members to be involved by speaking out against criminal activities unconditionally. "We encourage victims of rape to report incidents as soon possible and not to bath immediately as this will tamper with the evidence," said Minister Masutha.

"In this court, government will ensure that there is enough support to sexual offences victims. This is done through protecting victims and affording them an opportunity to testify in private," said Advocate Praise Kambula.

Disability Summit in Endumeni

The Endumeni Local Municipality hosted a successful Disability Summit in Dundee on 21 November 2018 as part of the National Disability Rights Awareness Month in preparations for the Disability Parliament that was hosted on 3 December 2018. This year's theme: "A Disability Inclusive, Barrie-Free South Africa by 2030 – Be the Legacy," responds to the agenda of the disability society.

It was the first time for Endumeni to host the Disability Summit and it was aimed at creating awareness and further engage on issues of disability right as enshrined in the Constitution. Thokozani Mkhize from the Albinism Society explained disability as the consequence of an impairment that may be physical, cognitive, mental, sensory, emotional, developmental or some combination of these.

Anti-corruption stakeholder engagement

The Government Communication and Information System facilitated a provincial dialogue on anti-corruption at the Sol Plaatje University on 21 November 2018. The dialogue was attended by faith-based organisations, public servants and community-based organisation, business sectors and Chapter 9 institutions of the Frances Baard District in Kimberley, Northern Cape.

The dialogue was aimed at mobilising all sectors in the country, including communities, to join the fight against corruption through individual and collective pledging. The Premier of the Northern Cape, Sylvia Lucas, delivered the keynote address and committed to establish a provincial Anti-Corruption Forum

intended to fight the scourge of corruption. Sol Plaatje University Vice Chancellor, Professor Yunus Ballim, reminded the audience about the role of the media and society in combating corruption. He said people conduct fraudulent or elicit activities simply because they feel entitled to certain things.

The level of influence, lack of consequence management and the issue of entitlement emanated during discussions as some of the causes of corruption. Attendees appealed for exemplary leadership and expressed that senior officials need to enforce accountability where officials were found to be corrupt. They also indicated that whistleblowers and their families need strict protection as they are exposed to attack once they reveal acts of corruption.
