

Speaking about their products and services, Neo Mogomotsi told small business owners that ABSA Centre for Entrepreneurship assists small businesses to become tomorrow's business giants.

"It takes just R390 for us to assist you to register your business with us, furthermore we will ensure that you get your CIPC Certificate, SARS Tax Clearance, Share Certificate and also assist you to get your business account with us," said Mogomotsi.

"Tax compliance is very important because through taxes, government is able to get revenue for service delivery and small businesses development support programme, hence it is important for you to comply with company tax, PAYE and VAT," said Hettie Laurens.

Gauteng departments of economic development and treasury emphasised more on the business compliance especially when it comes to doing business with government.

"You need to run a legal and compliant entity in order to benefit from any financial and non-financial support from the Department of Economic Development," said Clifford Mothibedi.

"Our department has a number of agencies that belong to it such as Gauteng Tourism, Gauteng Enterprise Propeller, Gauteng Gambling Board, Office of Consumer Affairs and Gauteng Liquor Board, all offering financial and non-financial support small businesses in their respective industries, however, you need to comply in order to benefit from their service and products," added Mothibedi.

Gauteng Treasury emphasised that businesspeople should register on the Central Database System by visiting [www.csd.gov.za](http://www.csd.gov.za) in order to benefit as suppliers of products and services to various government departments.

"To benefit from government supply chain as a supplier, you need to register your profile on the Central Database System of government. It is a system we use for Request for Quotations or Request for Proposals for suppliers in different industries for different services or products, to create a profile you need to have you CIPC Certificate, SARS Tax Certificate, BBBEE Certificate or affidavit to exempt your business from BBBEE Compliance," said Avuyile Cele.

"If your business' profit is less than R10 million you can apply for BBBEE exemption, all you need to do is to download the affidavit on CIPC website and complete it as directed, take it to the commissioner of oath to stamp it, so that your business is exempted and need not furnish the BBBEE Certificate," added Cele.






**Programme to workshop councillors**

The Integrated Councillor Induction Programme (ICIP) driven by South African Local Government Association in collaboration with the Eastern Cape Department of Cooperative Governance and Traditional Affairs, was launched in East London on 5 September 2016. The accredited programme targeting 1 490 new ward councillors who have just joined the local government sphere after the 3 August 2016 Local Government Elections was well attended by the leadership of the Eastern Cape Provincial Government, led by the Premier Phumulo Masualle. Traditional leadership, organised business and council of churches also shared messages of support.



**Prince Ncamashe said:**

“You have been elected by the people, you are expected to serve the people and be among them. There is nothing as bad as being a leader who is not even known by his people. You are given an opportunity to bring change and transform the society, it is upon you to leave a good mark or a bad mark during your term of office. 
The month-long programme, which kickstarted on 5 September 2016, will be rolled out to all district, metropolitan and local municipalities in the Eastern Cape.

Ehlanzeni Disaster Management hosted a successful and educational school debate on 19 August 2016. Ehlanzeni District is also one of the municipalities that are prone to disaster issues such as fire, thunderstorm, floods, etc. The topic was “Disaster Management is everyone’s business”. The district partnered with SANTAM to help communities understand, prepare, respond and recover from the impact of fires and floods. Sphetho Mhlongo, Ehlanzeni Disaster Management Manager said that this is the start of many debates and engagements around disaster management and that the district was looking forward to the annual debates. He also said that they would ensure that the overall winner walks away with a bursary next year.

**MEC launches the Batho Pele Mobile Clinic programme**



The Northern Cape MEC for Health, Lebogang Motlhaping, launched the mobile healthcare units called the Batho Pele Mobile Clinic. The initiative is a joint venture by Sishen Iron Ore Mine and the Department of Health and aims to ensure access to quality healthcare services in identified communities.



**Nametsegang Mathe said:**

“Yes. It is an exciting thing for our community. Healthcare services are now available for people right at their doorstep. As young people, we can use the clinic for many things pertaining to our health now.”

**Yvonne Pos said:**

“I am happy. People used to travel long distances to get treatment on time. I think the community is delighted. The clinic came at the best time because it will help to reduce the service delivery protests that have been happening in Kagung.”

“The project was initiated as a pilot project to benefit the rural communities of John Taolo Gaetsewe District through the provision of a comprehensive healthcare services package in mobile units,” said MEC Motlhaping. He said the handover was significant since it coincided with the Women’s Month commemoration and it is women who usually struggle with issues of healthcare.

According to Sydney Ntili from Sishen Iron Ore Mine, the partnership between the mine and government had been in existence for some years. By March 2016, the project had assisted 101 000 patients from communities in John Taolo Gaetsewe District.

The mobile clinics are seen as measures to save a lot of money and time for community members of Gasese, Maphiniki, Madibeng and Kagung, which are between 20 and 50 kilometres far away from health-service points.
