- 2.1.4. ukwazi zonke izixazululo ezikhona ze-GCIS ezimayelana nezicelo zokufinyelela kumarekhodi, ngaphambi kokuya kuMlawuli Wolwazi noma ezinkantolo;
- 2.1.5. ukuchaza izinsizakalo ze-GCIS ezhlinzekwa umphakathi nokuthi zitholakala kanjani;
- 2.1.6. ukuchaza umhlahlandela wokuthi isetshenziswa kanjani i-PAIA nokuthi ungayithola kanjani, njengoba ibuyekezwa nguMlawuli Wolwazi;
- 2.1.7. ukuchaza uma umnyango uzocubungula imininingwane yomuntu, inhoso yokucubungula imininingwane yomuntu kanye nencazelo yokwahlukana kwezihloko zemininingwane kanye nolwazi noma ukwahlkana kweminingwane ehlobene nalokhu;
- 2.1.8. ukwazi ukuthi ngabe i-GCIS ihlele ukudlulisa noma ukucubungula ulwazi lomuntu siqu ngaphandle kweRiphabhlukhi yaseNingizimu Afrika kanye nabanikezwa ulwazi noma izigaba zabamukela ulwazi lomuntu siqu olunganikezwa kubo;
- 2.1.9. ukwazi ukuthi i-GCIS inazo yini izinyathelo zokuphepha ezifanele zokuqinisekisa ukugcinwa kobumfihlo, ubuqotho kanye nokutholakala kolwazi lomuntu siqu okufanele lucutshungulwe.



3. UKUSUNGULWA KWE-GCIS

- 3.1. I-GCIS ingumnyango kazwelonke kaHulumeni weRiphabulikhi yaseNingizimu Afrika, owasungulwa ngokoMthetho Wezemisebenzi Kahulumeni we-1994. UMthethosisekelo weRiphabulikhi yaseNingizimu Afrika we-1996 uyisisekelo sokusungulwa kwe-GCIS.

Isigaba se-195(1)(g) soMthethosisekelo weRiphabulikhi yaseNingizimu Afrika we-1996 sihlinzeka ngokuthi, "Ukuphathwa kukahulumeni kumele kubuswe ngokwezimiso zentando yeningi labantu eziqukethwe kuMthethosisekelo, okubandakanya lokhu: **ukubeka izinto obala kufanele kugquqquzelwe ngokunikeza umphakathi ulwazi olufika ngesikhathi, olufinyelelekayo nolunembayo.**"

Ngowe-1998, uPhiko Lwezokuxhumana IwaseNingizimu Afrika Iwahlakazwa yabe iKhabbinethi isisungula i-GCIS, ngokwezincomo eziqukethwe embikweni weQembu Eliqokiwe Lezokuxhumana Kukahulumeni (Comtask: 1996: 58).

6. IZIXAZULULO ZE-GCIS EZIKHONA NGOKWEHLULEKA UKUTHATHA IZINYATHELO

- 6.1. Izikhalo zangaphakathi eziphikisana nesinqumo seSikhulu Solwazi se-GCIS
- 6.1.1. Umfakisicelo unelungelo lokufaka isikhalo kuNgqongqoshe ephikisana nesinqumo seSikhulu Solwazi uma isicelo solwazi sinqatshwa.
- 6.1.2. Uma iSikhulu Solwazi sehluleka ukuphendula isicelo sokufinyelela olwazini ezinsukwini ezingama-30 nanoma yisiphi isikhathi eseluliwe, umfakisicelo angafaka isikhalo sangaphakathi, ngokwenqubo echaphe lapha, ngaphambi kokuba umfakisicelo aye kuMlawuli Wolwazi noma eNkantolo.

- 6.1.5. Uma uNgqongqoshe engakuvumeli ukufakwa sekudlule isikhathi kwesikhala, kufanele azise umfakisicelo ngaleso sinqumo. Umfakisicelo ofaka isikhala sokwenqatshwa kwesicelo sakhe sokuthola ulwazi kufanele akhokhe imali enquyiwe yesikhala (uma ikhona).

- 6.1.6. Uma kukhokhwa imali enqunyiwe yesikhala zo sangaphakathi, isinqumo sesikhala zo sangaphakathi singahlehlisa kuze kukhokhwe imali. Ngaphandle kokuchitha isikhathi, kodwa uma kwenzeka kube phakathi kwezinsuku eziyi-10 zokusebenza ngemva kokuthola isikhala zo sangaphakathi, Isikhulu Solwazi se-GCIS kufanele sihambise kuNgqongqoshe:
