Consumer protection awareness campaign

The Government Communication and Information System in partnership with the Department of Trade, Industry and Competition held an awareness campaign on consumer protection and companies acts at Moletsi Thusong Service Centre on 27 March 2024. In total, 30 registered local business representatives were invited and received training on various acts.

According to Millicent Zwimbane who coordinated the event, the primary objective of the Act was to establish consumer rights and provide free, effective and efficient enforcement of those rights through the establishment of the National Consumer Commission, the National Consumer Tribunal accredited industry ombud schemes such as the motor industry with the aim of creating consumer rights and provide means of enforcement of consumer rights.

Among others, the attendees were educated about their rights to free and unlimited access to goods and services. They were also educated about their rights to demand quality services as they are entitled to timely performance and completion of services.

Human Rights Month embraces children's rights

The Government Communication and Information System (GCIS), Lovelife SA, Lifeline Durban, KwaZulu-Natal Department of Social Development and Ugu District Municipality shared information on this year's Human Rights Month under the theme: "Three decades of respect for and promotion of human rights" at Malangeni Secondary School, Scottsburg under Umdoni Local Municipality on 8 March 2024.

School learners were also given the opportunity to reflect on 30 years of their children rights. In addition, the learners were informed about safety tips for gender-based violence, Teenage Pregnancy, Sexual Abuse, contraceptives and use of condoms.

Ugu District Municipality, KwaZulu-Natal Department of Social Development, Umzinto Office, Lifeline Durban, Umdoni Sub-District and the GCIS conducted this Human Rights Month and gender-based violence and femicide (GBVF) awareness programme aimed at creating awareness for school learners about their rights and also solicit feedback regarding the 30 years of democracy and human rights.

Ugu District Municipality was represented by Nombuso Mpanza of Special Programmes Unit in Umdoni Municipality, who shared information about human rights, especially those of children.

The Department of Social Development (Umzinto) was represented by Sibongile Myeza, who shared some knowledge regarding GBVF awareness and teenage pregnancy. In addition, she advised learners to visit their office at Umzinto Town or South African Police Service should they encounter incidents and other social ills.

Myeza advised the school learners about psycho-social counselling services in order to keep their mental health to intact.

Learners were also informed about cyber bullying, substance abuse, rape and domestic violence by Lifeline Durban Social Worker, Buyi Mzobe and GCIS's Regional Communications Coordinator Khanyiso Seyisi respectively. The Department of Health encouraged learners to use contraceptives to avoid unwanted pregnancies and prevent HIV and AIDS infections.

Business incubator grooms small business

Department of Small Business Development Minister Stella Ndabeni-Abrahams officially opened the Gibela Business Incubator at Kwa-Thema Business Park on 10 April 2024. In her opening remarks, Minister Ndabeni-Abrahams said, "Today's launch of Gibela Business Incubator bears testimony of government's intent to transform small businesses into real game-changers and catalysts for economic growth and job creation."

The Gibela Business Incubator, a partnership between the Small Enterprise Development Agency (SEDA), the City of Ekurhuleni and the Gibela Rail Transport Consortium, benefits 291 township based Small Medium and Micro Enterprises (SMMEs). Gibela Rail Transport Consortium has invested R10.2 million in the facility, marking a successful private-public partnership initiative, which the Minister says is important because government cannot do everything alone.

"The SEDA incubation programme provides existing and aspiring entrepreneurs with a variety of essential services such as physical co-working space, shared infrastructure (co-creation spaces) and shared services," said Minister Ndabeni-Abrahams.

After undergoing incubation, SMMEs that are market ready graduate into independent enterprises. Five SMMEs in various sectors, which include baking and confectionary, Information and Communication Technologies, beauty, and cosmetics, graduated from the incubator's programme.

Through the Gibela Business Incubator, assistance provided to these SMMEs enterprises included getting products to be approved by the South African Bureau of Standards (SABS), accessing machinery through SEDA's Technology Transfer Programme, and participating in various business training and support services.

To ensure their sustainability and participation to transform the economy, small businesses require support and for consumer make a conscience decision to buy proudly South African products from these small businesses.

"We are here today to celebrate these small businesses, however, for them to succeed, we must buy their products and support our own," said Minister Stella Ndabeni-Abrahams.
