> Since the financial crisis, the question of how to unlock new sources of productive employment and strengthen the contribution of economic growth to progress in broad living standards has become an increasingly important concern for political and business leaders across the world. But while there is widespread international consensus on the need to develop new and improved growth and development models in this respect, little in the way of concrete policy guidance has emerged. There is a growing need for analytical frameworks and evidence-based solutions suited to this purpose.

The Forum seeks to contribute to an improved understanding of how countries make use of the diverse spectrum of policy incentives and institutional mechanisms available to expand social inclusion in the process and benefits of economic growth without dampening incentives to work, save and invest.

Building upon an initial discussion with World Economic Leaders at our Annual Meeting in Davos this year, this private session will be among the first in a series of regional public-private dialogues among the leading decision makers in Africa and globally aimed at tackling this challenge. During the session we will discuss the Inclusive Growth and Development Benchmarking Framework (developed by the Forum) and share some initial findings and key takeaways for the region. Participants will also be invited to share their feedback and initial reactions along the following dimensions:

- 1. What are the main obstacles to advancing inclusive growth in
- 2. What are the key policy instruments and business practices needed to deliver more inclusive outcomes from growth?
- 3. How can the public, private sector and civil society join forces to tackle this regional challenge?

allow them to make regular government-to-person (G2P) payments electronically. The funds being transferred are typically salaries or social benefits, which helps ensure that the right beneficiaries are paid in full and on time. However, many countries have recognized the need for additional efforts to make these electronic transfers a true stepping-stone to full financial inclusion. Moving beyond simple G2P programs to creating enabling ecosystems for full financial inclusion requires multistakeholder collaboration.

How can public and private sector institutions collaborate to develop an economically sustainable model for electronic delivery of G2P payments that promotes savings and provides recipients with access to a suite of quality, affordable financial services, including credit and insurance?

What will it take to enable additional electronic transactions (e.g. money transfers, purchase of basic goods and services) linked to these G2P transfers?
