Monitoring visit at Ugu District

The Deputy Minister of Higher Education, Science and Innovation, Buti Manamela, visited the Ugu District Municipality on 17 July 2020, as part of the response to the Cabinet meeting of 27 May 2020, which allocated Ministers and Deputy Ministers as District Champions.

The intention of the visit was to strengthen efforts to mitigate the impact of the COVID-19 pandemic and to enhance the response to gender-based violence (GBV).

Deputy Minister Manamela received presentations from Ugu District political leadership and government leaders where focus was mainly on tactics that have been used to fight COVID-19 and issues of GBV in the district.

The visit began at the Gamalakhe TVET College before proceeding to one of the rural schools located at Ward 29 of Ray Nkonyeni Local Municipality, Bashise Primary School, where a number of COVID-19 cases had been reported.

The Deputy Minister and Ugu District leadership concluded their fruitful monitoring programme by visiting the South Coast Mall where an activation was conducted to educate patrons on the importance to abiding by lockdown regulations.

On 10 July 2020, Sekhukhune District Municipality in partnership with SBS Water Treatment Company donated food parcels to 50 destitute families in Makgwaabe village in the Makhuduthamaga Local Municipality.

The District Executive Mayor Councillor Stanley Ramaila approached a company called SBS to intervene, after realising that there is still a shortage of food parcels after many food parcels were distributed through the food bank in Jane Furse.

Representing the District Mayor during the distribution of the food parcels, Member of the Mayoral Committee (MMC), Orginia Mafefe, thanked the SBS for their generosity during this critical period. "I thank the directors of SBS for coming into our rescue," said MMC Mafefe. As part of government's call to intensify its response to gender-based violence and femicide (GBVF), the Government Communication and Information System hosted a GBVF youth dialogue in partnership with the Department of Social Development, Japie Lepele Foundation and the University of the Free State in Lusaka, QwaQwa on 21 July 2020.

The objective of the dialogue was to provide a platform for young people to share ideas on how GBVF can be prevented and also recommend interventions that they deem necessary to end the scourge. Young people were also encouraged to be change agents in their communities.

Patriarchy and poverty were highlighted as some of the factors that fuel GBVF. Young people agreed that more structures needed to be established in the community to ensure the sharing of information. Another recommendation was that mass mobilisation of people at grassroots level needs to be conducted with the aim to encourage them to love one another irrespective of their race, gender and financial background.

Young people emphasised that women need to report violence and abuse cases to authorities, and should seek help from non-governmental organisations, social workers and other agencies dealing with GBVF. They were confident that the fight to end GBVF would be won once people in the community unite.
