### Awards for Early Childhood Development (ECD) practitioners

The South African ECD Awards partnered with government departments to recognise excellence, innovation, best practice and participation in the ECD sector throughout the country. The event, in its 11th year, took place in Lavender Hill, Bethlehem on 3 February. The National Development Agency (NDA) is currently hosting a series of provincial events to select winners that will also compete at national level on 26 March.

Zanele Makgethe, the ECD Coordinator from the Department of Social Development, said government is subsidising about 909 registered ECD centres and working together with the NDA to build brick crèches and alleviate shacks. The MEC for Social Development in the Free State, Sisi Ntombela, emphasised the importance of parents sending their children to ECD centres. She said ECD centres do not only keep children safe but also help them get education.

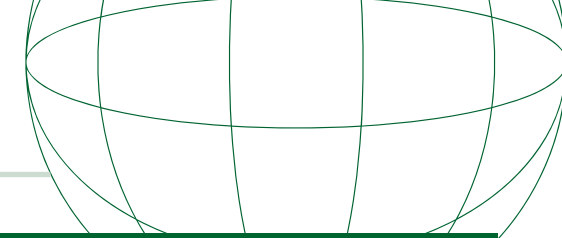

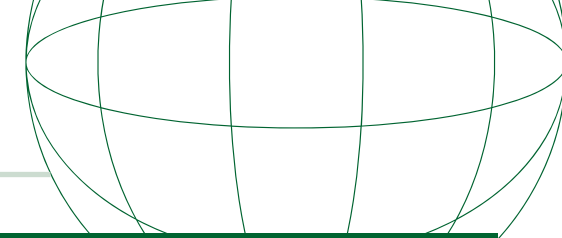

The Barberton community radio station has been operational for the past 17 years. It is currently under the management of Mduduzi Manana who is also the chairperson of the National Community Radio Forum in Mpumalanga. Manana said he is doing his best to sustain the radio station and he has the support of the community. The station has more plans such as rebranding to a more youthful image that will also be complemented with new jingles to be launched this month.

On 19 February, the Department of Communications (DoC) donated studio equipment to the radio station. The DoC believes that good broadcasting can only be possible if the station has all the right tools to execute its tasks. Sentech assisted with new equipment such as satellite dish, decoder and Return Channel Satellite Terminal to help the station to also cover parliamentary proceedings.

### Court Annexed Mediation launched in Mahikeng

The Minister of Justice and Correctional Services, Michael Masutha, launched the Court Annexed Mediation project at Barolong Boora Tshidi Hall in Mahikeng on 16 February 2015. The mediation programme serves as an alternative dispute resolution mechanism in which a mediator assists parties to reach a negotiated settlement at a faster and cheaper litigation cost. The programme also benefits unemployed law graduates to gain practical skills in dispute resolution and further assists courts to deal with clouded court rolls.

The North West MEC for Community Safety and Transport Management, Gaoage Molapisi, encouraged public servants to implement what President Jacob Zuma said during the State of the Nation Address: giving services to the people. The MEC explained that the community will not have difficulties in adapting and understanding how mediation works. He said the process has long been existing informally through pastors and community leaders, the only difference is that this time it will be done by qualified mediators. A staged drama in which a mother asked for mediation for a maintenance dispute was demonstrated to explain the process.

Minister Masutha delivered a keynote address where he said, “A good government is judged by how it serves its people regardless of their gender, race and education.” The Minister highlighted difficulties that poor people encounter when approaching the courts. Disputes can take over two years to resolve and court cases are expensive compared to mediation, which focuses on civil and family disputes and is underpinned by Ubuntu. The Minister also spoke against corruption and violence.

Certificates were handed over to mediation clerks. At least 55 graduates were targeted in the initiation phase and are based at identified sites across all nine provinces. Moretele, Molopo and Potchefstroom have been identified within North West. An Imbizo followed during the second phase of the programme and community members were able to raise their questions, comments and concerns. Community members also received educative information from exhibitors such as the departments of communications, justice and constitutional development, social development, National Prosecuting Authority, South African Social Security Agency, South African Police Service and many others.



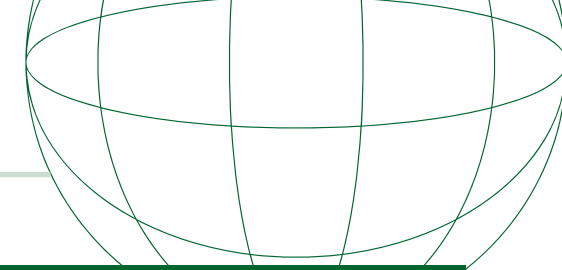

### Deputy Minister reaches out to young people

Young people from all four local municipalities in the Alfred Nzo District Municipality gathered at a conference centre for a post-SoNA panel discussion on the draft National Youth Policy (NYP) 2020.

The panel discussion took place on 24 February and was led by the Deputy Minister in The Presidency, Buti Manamela. The youth engaged the Deputy Minister and expressed their views about how they envisage youth development in South Africa.

Issues raised by the youth ranged from the education system and how it should be improved, skills development, the country’s procurement policy and how it should be improved to ensure beneficiation and participation of young people in the mainstream economy, and the National Youth Development Agency (NYDA).

This post-SoNA panel discussion served as a platform for the Deputy Minister to consult with the youth of Alfred Nzo District Municipality as his office is currently engaging different youth formations for the draft NYP 2020. The policy has four broad areas of priorities: economic transformation and participation, education and skills development, behavioural change as well as social cohesion and active citizenry.

After the panel discussion, the youth received information on youth development from government departments and agencies such as Small Enterprise Development Agency, departments of labour, roads and public works, Skills Education Training Authorities supporting mechanical and electrical engineering as well as other related services.
