March tackles violence against women and children

Violence against women and children has prompted civil society groups and government to work together and speak in one voice against gender-based violence (GBV). On 10 October 2019, the Department of Community Safety and Liaison, and the Emphithi Empowering Project led a team of government departments, non-governmental organisations and students in a three-kilometre march and dialogue aimed at raising awareness about GBV in Pietermaritzburg. The event has created a platform for young leaders to speak out about the plight of GBV.

Speaking on behalf of the Durban University of Technology students, Olwethu Ncoweni, said that students were tired of daily reports on GBV. "We are here today to make a mark so that our future generation does not suffer the same experience," he said. Ncoweni also added that the fight against GBV should become a collective effort. The event concluded with the signing of a pledge by several sector representatives as a commitment to fight against all forms of abuse.

Government has established the Gender-Based Violence Command Centre (GBVCC) to provide support services to victims of GBV. Callers can be assisted in any of the 11 official languages. Campaign tackles gender-based violence

The Government Communication and Information System, together with the Foundation for Victims of Crime (FOVOC), Childline South Africa, Thuthuzela Care Centre and the South African Police Service hosted a mall activation on 23 September 2019 at KG Mall in Emalahleni Local Municipality. The event sought to empower the community with information on how to report gender-based violence (GBV) and child abuse.

Community members were also informed about the danger of not reporting GBV and child abuse cases. Information leaflets with contact details were distributed and some community members came to the Thuthuzela Care Centre where they were offered assistance to open cases.

Speaking on behalf of FOVOC, Samantha Sibande said, “We have a centre that houses victims of abuse, we therefore urge victims to come forward and not stay in abusive relationships.”

The Emalahleni Thuthuzela Centre also conducted interviews with Emalahleni FM to raise awareness on how they can assist victims of abuse.

Thuthuzela care centres are one-stop facilities based in public hospitals to assist people who are victims of abuse. They seek “to reduce secondary trauma for the victim, to improve conviction rates and to reduce the cycle time for finalising cases”. Government is currently in the process of enhancing operations in all centres to ensure that they are fully functional. Government assists drought stricken farmers

Deputy President David Mabuza visited the Aggeney community, in the Northern Cape on 4 October 2019 with the purpose of engaging with local farmers in Namakwa District Municipality. The visit comes amid calls by farmers to declare the area as drought-stricken. Farmers in the district were afforded an opportunity to raise factors that affect their ability to farm effectively.

The Deputy President met the Maasdorp family who represented other drought affected farmers during this visit. The family reiterated that they had to reduce their livestock from 700 sheep to just 90 because of severe drought.

Deputy President Mabuza committed that government would collaborate with the private sector to provide urgent relief to the Northern Cape farming communities, more especially those whose livestock is mostly affected by drought. Several measures have been established. Government has allocated an estimated amount of R30 million for immediate intervention in the procurement and distribution of fodder for the farming community as a short-term measure.

Moreover, government has promised to collaborate with stakeholders within the agricultural sector to ensure a coordinated approach to the challenge of drought that is severely affecting the area. It has also committed to help with the production of fodder to increase the current capacity of the Fodder Bank, established in the province.
